- Two hundred seven (207) RSUs vested immediately with the remaining RSUs vesting on the earlier of (a) May 20, 2021 or (b) the day before the issuer's next annual meeting of stockholders. The RSUs are payable upon vesting.
- The RSUs have no expiration date.
